- Box reference I.28: *Nature of commodity*: Indicate 'carcass-whole', 'carcass-side', 'carcass-quarters', 'cuts', or 'minced meat'.
- Box reference I.28: *Treatment type*: If frozen, indicate the date of freezing (mm/yy) of the cuts/pieces.

- (<sup>2</sup>) Date or dates of slaughter. Imports of this meat shall not be authorised when obtained from animals slaughtered either prior to the date of authorisation for exportation to the Union of the third country, territory or part thereof referred to in boxes I.7 and I.8, or during a period where restrictive measures have been adopted by the Union against imports of this meat from this third country, territory or part thereof.
